Participant acknowledges that such directions are vital for the safety of all Course participants. Failure to follow directions from the Instructor may result in Participant's ejection from the Course without refund of any monies paid to RP Shooting Sports, LLC for participant's attendance. ("Instructor" also includes Range Officers) Initial
